In terms of **J&K Compassionate Appointment Rules, 1994 notified vide SRO 43 dated 22.02.1994** as amended from time to time, sanction is hereby accorded to the temporary appointment of Shri Tanveer Ahmad Dar S/O Mohammad Akbar Dar (Deceased Fireman-1674) R/O Rakh Shilvath Tehsil Sonawari District Bandipora, as Fireman in the Pay Band of Rs.5200-20200+GP1900/-(now revised Level-2 1990-63200) plus usual allowances as admissible under rules.

The appointee shall report for duty at Fire & Emergency Services Station, Sopore within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

1. Academic qualification certificate.
2. Age and health certificate.
3. Permanent Resident Certificate.
4. Dependence Certificate issued by Assistant Commissioner Revenue.
5. All relevant documents as required under SRO 43/1994.
6. No loan certificate under self-employment Scheme from DIC concerned and Employment department.

The appointment of the appointee shall further be subject to the following conditions:-

- a) That he shall give an undertaking in the shape of Affidavit to the effect that:-
 - i) In case **adverse** report about his Character and Antecedents is received from the Inspector General of Police, (CID) J&K, to whom a reference will be made, he shall have no right to claim his appointment as Fireman in the department and his appointment, as such, shall be deemed to have been cancelled **ab- intio** and the legal action as warranted under rules shall be initiated against him.

- ii) If, on verification, genuineness of the D.O.B/Qualification certificate from the concerned issuing authority is found that the same is fake/ forged, the claim of the appointee for appointment as Fireman shall also be deemed to have been cancelled **ab-intio** and the legal action as warranted under rules shall be initiated against him.
- b) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of (i) and (ii) above are received in his favour.
- c) The appointment of the candidate shall be governed by the "**New Pension Scheme**" as per SRO-400 of 2009 dated 24.12.2009.
- d) The appointee shall be on **probation** for a period of two years.
